1. Categories of Personally Identifiable Information Collected

a. Traffic Data Collected

NAPP automatically gathers general statistical information about visitors to the Site. Accordingly, NAPP may track and collect certain technical information from You when You visit the Site. This may include: (i) Your IP address; (ii) Your geographical location; (iii) the pages You viewed; and (iv) the goods and services You purchased (hereinafter collectively "Traffic Data"). Traffic Data is anonymous information that does not personally identify You, but which may be used for improving Your experience on Our Site. Traffic Data may be provided to third parties. NAPP may also use "cookies" for specific purposes such as storing Your password so that You do not have to re-enter it each time You visit the Site. A cookie is a small piece of information that is stored by Your browser on Your hard drive. Most Web browsers automatically accept cookies, but if You prefer, You may set Your browser options to block them in the future.

b. Personal Information Collected

d. Financial Data

NAPP will not share Your Financial Data with third parties other than as expressly provided for herein.

4. Confidentiality and Security of Personal Information
